

West Virginia Virtual Academy Title I Parent Involvement Policy

PART I GENERAL EXPECTATIONS

- West Virginia Virtual Academy (WVVA) will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1116 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- 2. Consistent with section 1116, WVVA will work to ensure that the required schoollevel parental involvement policies meet the requirements of 1116(b) of the ESEA and each include, as a component, a school-parent compact consistent with section 1116(d) of ESEA.
- 3. WVVA will incorporate this parental involvement policy into its LEA plan developed under section 1112 of the ESEA.
- 4. In carrying out the Title I, Part A parental involvement requirements, to the extent practicable, WVVA will provide full opportunities for the informed participation of parents and family members (including parents and family members with limited English proficiency, parents and family members with disabilities and parents and family members of migratory children) including providing information and school reports required under section 1111 of the ESEA in an understandable and uniform format and, including alternative formats upon request, and, to the extent practicable, in a language parents understand.
- 5. If WVVA's plan for Title I, Part A, developed under section 1112 of the ESEA, is not satisfactory to the parents and family members of participating children, WVVA will submit any parent comments with the plan when it is submitted to the State Department of Education.
- 6. WVVA will involve the parents and family members of children served in Title I, Part A schools in decisions about how the one percent of Title I, Part A funds reserved for parental and engagement policy is spent, and will ensure that not less than 90% of the one percent reserved goes directly to the schools.
- 7. WVVA will use funds reserved under subparagraph (A) to carry out activities and strategies consistent with the parent and family engagement policy, including not less than one of the following:
 - a. Supporting schools and nonprofit organizations in providing professional development for school personnel regarding parent and

family engagement strategies, which may be provided jointly to teachers, principals, other school leaders, specialized instructional support personnel, and parents and family members.

- b. Supporting programs that reach parents and family members at home, in the community, and at school.
- c. Disseminating information on best practices focused on parent and family engagement, especially best practices for increasing the engagement of economically disadvantaged parents and family members.
- d. Engaging in any other activities and strategies that WVVA determines are appropriate and consistent with the parent and family engagement policy.

8. WVVA will inform parents and parental organizations of the purpose and existence of the Parent Information and Parent Resource Center in the county and the state.

PART II DESCRIPTION OF HOW WVVA WILL IMPLEMENT REQUIRED PARENTAL INVOLVEMENT POLICY COMPONENTS

■WVVA will take the following actions to involve parents in the joint development of its parental involvement plan under section 1112 of the ESEA;

- 1. Include parent representatives in a Title I parent advisory capacity on an annual basis to review/revise the county wide Parent Involvement Policy.
- 2. Provide Local School Improvment Council (LSIC) with information regarding the parent involvement plan.

■WVVA will take the following actions to involve parents and family members in the development of support and improvement plans under section 1111(d) of the ESEA:

- 1. Parents will be notified of the status of their child's school annually.
- 2. Parent will be represented in the development of the School Plan.
- 3. Parents will be represented on the LSIC.

■WVVA will implement effective parental involvement activities to improve student academic achievement and school performance:

1. Provide funding for parent involvement academic activities.

- 2. Provide coordination time for Title I teachers to plan appropriate parent involvement activities.
- 3. Provide communication to Title I parents and families regarding Title I parent involvement activities.

■WVVA will coordinate and integrate parent and family involvement strategies in Title I, Part A with parent and family engagement strategies under the following other Federal, State, and local programs, by:

- 1 Inviting parents from the aforementioned programs to participate in parent involvement activities;
- 2 Making services/materials available to the aforementioned parent programs.

■WVVA will take the following actions to conduct an annual evluation of the content and effectiveness of this parental involvement policy in improving the academic quality of its Title I, Part A School. The evaluation will include identifying barriers to greater participation by parents in activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background.) The school will use the findings of the evaluation about its parent and family engagement policy and activities to design evidence-based strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents and family members) its parent and family engagement policies.

- 1. Input will be solicited from the parents of Title I children.
- 2. The evaluation will incorporate the information provided by Title I parents.
- 3. The administration and compilation of results from the evaluation instrument will be done by the Title I Director. Results will be given to the Title I Advisory Committee.

■WVVA will build the school's and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents and the community to improve academic achievement, through the following activities specifically described below:

- A. The school will provide assistance to parents of children served by the school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph—
 - The challenging State academic standards,
 - The State and local academic assessments including alternate assessments,
 - The requirements of Title I, Part A,
 - How to monitor their child's progress, and
 - How to work with educators:

- 1. Parents will be informed of grade reports, their formats, etc. with report cards every semester.
- 2. Parents of children participating in the alternate assessment will receive information regarding that instrument at IEP meetings.
- 3. Parent-Teacher Conferences
- 4. Curriculum Nights

■WVVA will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- 1. Providing training on how to work with their child in mathematics;
- 2. Providing training on how to work with their child in reading;
- 3. Providing worksheets, puzzles and other academic reinforcers; and/or
- 4. Providing discussion threads on the LC Community with information regarding learning activities.

■WVVA will educate its teachers, specialized instructional support personnel, principals and other school leaders, and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- 1. Providing educators with training regarding working with parents; and
- 2. Developing programs that encourage parent and teacher involvement in the child's education.

■WVVA will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with other Federal, State, and local programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.

WVVA will take the following actions to ensure that information related to the school and parent-programs, meetings and other activities, is sent to the parents of participating children in an understandable and uniform format, and, to the extent practicable, in a language the parents can understand.

- 1. WVVA will utilize available resources to ensure that all information is understandable and uniform, in language parents can understand.
- 2. WVVA will review parent materials prior to making available to parents.
